Kristi Daugherty, Chief Executive Officer provided the following information:

- Community collaboration presentation was provided highlighting EHN's work in the community expanding partnerships in several areas.
- EHN is offering retention incentives to clinical staff raging from \$1k-\$3k which will be divided into two payments and includes caseworkers, service coordinators, residential care employees. Health fund savings will be used to pay for incentives.

- EHN's budget planning is progressing; Texas Council is confident that the 1115 Waiver Extension will be reinstated. EHN is anticipating \$1 million more than anticipated in April in 1115 Waiver funding for this year.
- The bridge back plan is working as designed
- A bill which was passed regarding constitutional carry allowing individuals to carry a firearm without a permit is raising concerns across the state
- Board of Trustees training with Open Minds is scheduled for August 31, 2021; budget planning sessions will occur in the month of August
