A. Receive CEO report regarding current EHN crisis operations and financial impact

Kristi Daugherty, CEO reported the following:

- Remote audio codes have been extended through October 23, 2020
- August 3rd Anniversary CEO provided interviews for KFOX, CNN and El Paso Inc. Article provided by EHN will be featured in the El Paso Inc.
- MOU between NAMI/EHN has been executed to assist NAMI with office space at the Central Administration Office
- Notification was sent to all board members including a list of division budgets which will be presented each day, 11 divisions will be covered in four days; Aug. 18th and 20th will be designated as make up sessions
- Proposed Strategic Plan timeline consist of the FY20 completion which will be
 presented at the August Board meeting. FY21 draft plan will be distributed for
 initial review in August and will be presented with tasks during September
 committees for discussion. FY21 Strategic Plan will be presented at the September
 Board meeting.

Rene Navarro, Chief Compliance Officer, reported the following:

- A Bridge Back Plan associate checklist has been generated which consists of a series of steps to be followed center-wide including:
 - o COVID employee testing
 - Message from the CEO in form of video/letter
 - Management and safety liaisons will be trained to become trainer of trainers and be of assistance in case anyone has questions
 - o Environmental controls were put in place such as facility signage and installing plexiglass

Dr. Tewiana Norris, Chief Nursing Officer, reported the following:

- Working closely with the Public Health Department to obtain testing kits
- Employees returning to work will be tested for COVID
- 1600 Montana has been designated for COVID testing; preparations are being made for flu vaccinations in mid-September
- Other vaccinations will be offered to include Hepatitis B

Rene Hurtado, Chief of Staff provided the following:

- EHN remains active in the preparation of the August 3rd Anniversary
- Both the City and County are leading efforts city-wide; people will be setting up luminarias outside their doors and a groundbreaking of the reflection pool memorial is scheduled at Ascarate Park
- Monday August 3rd is designated as a day of kindness
- Love for El Paso Art show
- A Zoom Help the Helper session for first responders on post-secondary trauma was held on Aug. 29th focusing on self-care tips
- On August 3, 2020 EHN will conduct Facebook live sessions from 8 AM to 4 PM with members of the clinical staff highlighting various self-care topics
- Walmart will close store from 8:00 AM Noon; employee only event will be held during this time
